ROLE PURPOSE:

To protect public and animal health at the border by providing Official Fish Inspector (OFI) presence at London Heathrow Airport for imports of fishery products (Products of Animal Origin - POAO) and to enforce statutory requirements for imports of food and feed not of animal origin (FNAO).

Provide an effective and efficient service on behalf of the London Borough of Hillingdon in respect of imported food functions at Heathrow Airport's Border Control Post. Undertake official statutory controls including verification of import documentation and examination and sampling of products.

Exercise professional judgement and carry out all enforcement work in line with Council policies procedures, relevant national guidance and codes of practice, taking legal responsibility for the final decision made.

A. Job Description

1 Resident & Community Contribution

- Demonstrate understanding of the Council's Customer Care Standards and ensure that these standards are met in order to deliver the Council vision of 'putting our residents first'.
- Deliver projects and campaigns to promote the service to our customers.

2 People Management

- No direct supervisory responsibility however there will be a requirement to guide and support the Technical Officers and support staff.
- Assist in induction and training of peers, new employees & apprentices and other staff as required.

3 Operational Service Delivery

- Responsible and accountable for the decision making on the outcome of controls on:
 - Fish and Fishery products (Products of Animal Origin) for human consumption
 - Products Not of Animal Origin (PNAO)
 - o Illegal, Unregulated and Unreported fish controls
 - Organic Imports
 - Materials in contact with food
- Undertake the sampling of food and water for microbiological and chemical analysis, and to interpret and communicate results.
- To sign statutory notices in relation to delegated duties undertaken in accordance with established guidelines.
- Maintain detailed knowledge of all relevant legislation relating to the role, including maintaining relevant levels of Continuing Professional Development.

- Oversee and provide advice to Technical Officers and support staff in the execution of all relevant duties ensuring delivery is consistent and appropriate.
- Communicate import requirements with importers and clearing agents to ensure that legislative requirements are met in relation to consignments, including those rejected at the BCP.
- Undertake manifest checks on flights and consignments arriving into Heathrow Airport.
- Undertake random searches of cargo in the Airline Temporary Storage Facilities and take any necessary enforcement action.
- Deliver in a consistent, proportionate and transparent manner to meet statutory and service requirements.
- To manage with a minimum level of supervision your own workload including a personal caseload assigned by the Principal Environmental Health Officer.
- Technical supervision of internal and external stakeholders operating at the Border Control Post.
- Work with outside organisations involved in the work of the BCP including; Heathrow Airport Limited, importers and exporters, local clearing agents, Government departments, UK Border Force, Animal and Plant Health agency, Official Control Laboratories, and other Border Control Posts.
- To develop new ideas and proactively assist the Senior and Principal Environmental Health Officers with development of procedures, to improve efficiencies using best practice. To actively participate in reviewing relevant legislation and initiatives.
- Assist in the production of reports to council committee and other bodies.
- Maintain all records to comply with requirements of the service, external agencies and government.
- Provide and receive management information, maintain records and national and international databases, maintaining confidentiality.
- Maintain awareness of the Council's legal duties and policies on Health & Safety, equality and customer care, and ensure that they are implemented in practice.
- Act responsibly within the working environment, evaluating risks and adhere to safe working practices. Reporting hazards, incidents and accidents so that reasonably practicable measures are taken in the workplace.
- To be aware of the Councils responsibilities under the General Data Protection Regulations ensuring the security accuracy and relevance of all personal data held.
- Assist with Water Sampling and Aircraft Disinfection duties as part of general Port Health requirements of international health regulations.

4 Service Planning & Development

- Maintain knowledge of the current Team Plan and understanding of own contribution in order to ensure delivery of this plan.
- Assist service management in promoting and maintaining service standards.
- Support development of strategy, policy and procedures and implementation in line with organisational objectives of continuous/business improvement delivery.

5 Financial & Resource Management

- Demonstrate cost-consciousness and identify any cost-effective changes to own way of working.
- Proactively plan and programme work to facilitate the most efficient use of time and resources.
- Ensure correct payment is received and processed for consignments.

6 Service Improvement

 Identify and suggest any improvements to current ways of working in order to deliver a more efficient and effective service for customers.

7 Contacts

 Primary contact will be with businesses, central government departments and agencies, service users and residents.

Internal: All council departments which are relevant to the business of the service; senior managers, elected members as appropriate.

External: Central government departments and agencies, other local authorities, contractors, Heathrow Airport Limited, traders, pressure groups, industry and commerce, Politicians, Solicitors, Barristers, Court Officials and witnesses, Government Chemist.

8 Additional Responsibilities

- Complete other reasonable tasks in order to fulfil the role purpose or as required by management. Including secondment to Food Health and Safety when demand requires.
- Work outside of normal working hours as required.
- Required to participate in the out of hours standby services.

9 Key Performance Indicators - examples

- Corporate response for times for letters, emails and telephone calls.
- Compliance with agreed SLAs and service standards, e.g. processing of food import documentation etc.
- Delivery of agreed performance and development appraisal (PADA) objectives.
